#### Greetings to you,

India, along with ten other WHO South East Asia Region member countries, has resolved to eliminate measles and control rubella/congenital rubella syndrome (CRS) by 2020. In this direction, Ministry of Health & Family Welfare has initiated measles-rubella (MR) vaccination campaign in the age group of 9 months to less than 15 years in a phased manner across the nation. The campaign aims to cover approximately 41 crore children.

The Measles-Rubella campaign is a part of global efforts to reduce illness and deaths due to measles and rubella/CRS in the country. Measles immunization directly contributes to the reduction of under-five child mortality, and in combination with rubella vaccine, it will control rubella and prevent CRS.

Ministry of HFW wishes the schools to join hands in the same campaign and we are asked by the government of Rajasthan to conduct the same campaign in our School. We are happy to announce that the vaccinations will be given in the school premises. Though the authorities have confirmed that vaccination is totally secure, and vaccinations are already done in many schools without any major concerns but the final decision of giving vaccine rest with the parent. We therefore ask you to fill the consent form sent with your ward and send it back to us within 2 days of receipt as we must arrange for the same(A copy of consent form is also attached). **The date of vaccination given to us is 12**<sup>th</sup> **of September 2019.** 

#### Kindly note the following to avoid any inconvenience to the child: -

- 1. All students from grades Nursery to X must report to school as per regular timings and must have breakfast.
- 2. Parents of students of **Pre-Primary and grade I** must come to school as per the time slot shared below. These students will be sent back home after the vaccination is administered.
- 3. Pre- Primary students and students of grade I are requested not to carry school bag.
- 4. Dispersal for students of grades II to X will be as per regular school timings.
- 5. The students with medical concerns like epilepsy, fever above hundred degrees and on any medication/steroid are requested not to take MR Vaccination
